About the Event

Players of all levels are welcome to a fun-filled afternoon of golfing for a good cause. The game will be played in the System 36 Shotgun format for the 18-hole challenge, followed by dinner.

What Psaltcare does

Psaltcare actively supports the recovery journeys of persons with mental health conditions such as depression, anxiety, bipolar disorder and addictions. We conduct psychoeducation classes, recovery talks and workshops, and run support groups which are facilitated by trained, volunteer peers-in-recovery to provide support and encouragement to help other peers in their recovery.

Why your support matters

In Singapore, the lifetime prevalence of mental illness of 13.9% (or 1 in 7 persons) in the adult population is steadily rising, up from 12% in 2010. Mental health conditions also account for 11% of the life-years lost to disability in Singapore. However, according to the latest Singapore Mental Health Study, more than 75% of persons with mental health conditions do not seek professional help.

Psaltcare addresses this growing social need by providing more accessible, peer-focused mental health care within the community. Your support will go a long way in addressing the multiple barriers to recovery faced by peers, including discrimination, perceived stigma or shame attached to disclosing mental health conditions, debilitating symptoms and other life challenges creating multiple pressures and persistent stress on peers, which results in increased suicide risk.

Your donation will contribute towards the setting up of an activity hub and short-term respite haven to provide comprehensive, sustained support to peers through a wider range of psychoeducation and recovery skills training. This supports peers in their individual progress plans and enhances their resilience as they recover and re-adapt to life and work anew.

Psaltcare is an Institution of a Public Character. As such, all donations towards the charity event will be eligible for a tax deduction of 2.5 times of the donation sum against the donor's taxable income. Additionally, the Government has announced that as part of the Bicentennial Community Fund, all donations received for the period April 2019 to March 2020 will be matched dollar-for-dollar by the government's charity funding agencies. This means that for every dollar you donate to Psaltcare, we will have twice the resources to provide services to the community.
